The purpose of this visit was to look at Kapstone's safety program. This venture was a joint effort of the Labor/Management

Safety and Health Committee from MeadWestvaco, Covington, and the Kapstone Safety Team. The Covington folks appreciated the hospitality and insight that was afforded to them by Kapstone and their employees. Kapstone has some good programs in place, such as an onsite physical therapist.

Her record, however, speaks differently. Instead of supporting policies that would create living wages here, Rep. Herrera continues to support policies that benefit the corporations that are off-shoring our jobs.

Brothers and Sisters, the following is a news release I jobs, especially manufacturing jobs, we currently have the lowest levels of employment in pulp, paper, sawmills, and plywood mills than at any time in the last 20 years. U.S. plant sites continue to close; the equipment dismantled then shipped overseas and brought back online producing the very same products that were being manufactured here. Rep. Herrera is proud of the fact that raw log exports from the Pacific Northwest are at record highs. This should come as no surprise to anyone because Rep. Herrera continues to support a U.S. trade agenda that results in the export of our raw materials such as logs, coal, oil and natural gas along with exporting our family wage jobs."

In fact, the workforce at every pulp and paper manufacturing plant site in Representative Herrera's district has been approved for the Department of Labor's Trade Adjustment Assistance (TAA) program. To be TAA certified workers must be directly impacted by imports or by a shift in production of their firm to any country with a free trade agreement with the United States.

The impacts reach far and wide. When jobs are offshored, the flood of unemployed workers drives down wages and benefits in all sectors. "We've had twenty years of NAFTA-style free trade, and the results are in: these so-called free trade agreements are hurting workers. Far too many families here in Washington State have suffered by having their livelihoods shipped overseas because of bad trade policies," says Gillian Locascio of the Washington Fair Trade Coalition, "No job fair can reverse the off-shoring; we need trade policies that promote family wage jobs."

Yet Rep. Herrera remains trapped in an outdated vision for trade. She continues to support the Trans-Pacific Partnership, which is being negotiated with a dozen Asian and Latin American countries. Corporations have had a place at the negotiating table through some 600 approved trade advisors, but the text of what would be the largest "free trade" agreement in U.S. history has been kept secret from the rest of society. Rep. Herrera even supports lowering Congressional oversight by passing Trade Promotion Authority, also called Fast-Track legislation, which would limit Congress to a simple up or down vote of the finished agreement, with limited debate or public input.

Locascio adds, "The Trans-Pacific Partnership includes countries like Vietnam and Malavsia, where workers are paid even less than workers in China. U.S. employers would have to compete with products made in sweatshop working conditions and with few environmental or safety protections."

Rep. Herrera has invited Weyerhaeuser and Georgia Pacific, two companies notorious for off-shoring jobs, to recruit at the job fair, as well as Walmart, equally notorious for maintaining a work force that relies on tax dollars to support their basic needs such as food and healthcare.

Bill Spring, President, of AWPPW Local 5, Georgia Pacific, Camas, Washington, calls for lasting solutions:

"Again this year we ask Rep. Herrera, 'Is this the best you can do for the workers in our district? In the future don't support so-called "free trade" agreements that off-shore our jobs. Be a job creator, not a pawn, for corporations like Weyerhaeuser, Kapstone, and the Koch-owned Georgia Pacific Corporation.""

Kapstone has reached its safety goals by using fear and intimidation. Many employees volunteered information that not all incidents and accidents are being reported based on retaliation from the employer. Employees also reported company leadership has openly stated the management team can drive the incident and accident rates to near zero by emphasizing discipline. These approaches actually increase the possibility of a catastrophic accident rather than helping to create a safer work environment.

This creates a serious matter which the union leadership has brought up with the Kapstone's plantsite managers and also with the company's corporate leadership team.Complaints have also been filed with Washington State Labor and Industries.

But all is not lost. The Covington representatives gained some valuable pointers from the visit to Kapstone.

Workers' Health Matters Improve Some

HB-4104

HB-4104 was signed into law on April 4th 2014 by the governor! If you recall. HB-4104 allows an injured worker to receive medical treatment in a timely manner whether or not it is Workers' Comp related. This was not an easy accomplishment as it needed to pass through the Management-Labor Advisory Committee (MLAC) before going to the governor.



The MLAC was established in 1990 with the purpose of studying issues affecting Workers' Comp, and reporting those findings to the legislature. The governor will not sign any Workers' Comp bill without the MLAC's blessing. Unfortunately, to move anything through the committee, requires a majority from the five labor and five management members.

Here, we should thank Representative Paul Holvey (D-Eugene), a member of the United Brotherhood of Carpenters (UBC), for his persistence. Rep. Holvey chairs the Consumers Protection and Government Efficiency Committee.

In August of 2013, the issue of delaying medical treatment for workers, until knowing if the injury was a Workers' Comp claim, came before this committee. Rep. Holvey then had a ters was sorry to hear that concept draft of the bill. He presented this draft three times to his Lenard "Lenny" Roberts committee before they endorsed the final version and voted for it passed away in mid April afunanimously.

At the time, injured workers were forsaking the Workers' Comp system and going to their own health care provider to avoid the delay in medical treatment. So, from now on, if you are injured at work, HB-4104 allows you to get medical treatment right away, before the determination of what the injury is declared. This allows for a quicker recovery and a faster return to work.

Workers' Comp Ombudsman

Another person I want to mention is Jennifer Flood, Workers' Comp Ombudsman for Injured Workers. The office of Ombudsman is an independent advocate for Oregon's injured workers. The office can help you informally resolve problems which may arise when you file a Workers' Comp claim. Jennifer Flood is great to deal with and was of great help to Rep. Holvey in getting HB-4104 to become law.

Health Care for All Oregon

Health Care for All Oregon (HCAO) is a group which has been formed to get health care reform leaning towards a single payer insurance plan. I have been going to meetings of this organization for about a year. They are gearing up for a ballot measure and/or a bill to go through the legislature by 2016. Considering that health care costs have risen three times faster than wages makes this a huge issue for the AWPPW.

AWPPW members are covered for health care because it has been negotiated into contracts with the employers. But that is even a risk today, and we all know of people (friends or family) who have no medical coverage. HCAO is an opportunity to do

better for everyone. Interestingly, the Public Citizen did a study on health care in 2012. In it they stated: Canada has a lower infant mortality rate; they live longer than we do in the U.S.; they pay half of what we do for health care, but they smoke and drink more than U.S. citizens. Sign me up for that program! Seriously, health care is an urgent issue and has to be dealt with. I will continue to track this for a while to come.

This will allow you to better inform your local union's delegates to the AWPPW's Oregon-Idaho-Utah Area Council as to who should receive endorsement at the September Area Council meeting.

Lenard B. Roberts

The AWPPW headquarter a long illness. He was 77. Roberts was an "Original Rebel", having moved to the west coast from his home state of Missouri, with wife Marjorie, in 1961, and went to work at the mill in North

Bend, Oregon, then owned by Menasha. The mill was later acquired by Weverhaeuser Company. Roberts served his Local

1000 consistently as president and council and convention delegate all the way from 1976 until 1995.

He occasionally served on the local's Standing Committee also.

Len Roberts also was also very active with both the AWPPW Oregon/Idaho/Utah Area Council and the Weverhaeuser Coordinating Council, and served officer positions with both councils, up to and including president.

Roberts became elected as President of the AWPPW and served in that position from 1995 to 2002, before going into full retirement.

Lenard's hobbies were fishing and hunting, but especially pheasant hunting, which he enjoyed along with his wife and his cherished hunting dogs.

Roberts is survived by his wife, Marge, who he married in August of 1955; son Rick, daughter Sandy, and two grandchildren. Son Rick had also worked at the mill in North Bend.

A memorial service was held at the Church of Christ in North Bend on May 10th.



Local 13 Hosts OR-ID-UT Council

The Oregon Idaho Utah Area Council meeting was hosted by AWPPW Local 13 (Toledo, OR) on May 15th and 16th, at its union hall in Toledo. AWPPW President John Rhodes, Vice President Greg Pallesen, Secretary Jim Hassey, Area Reps Ken Hardwick and Don Draeger, and Relief Area Rep Bill Martello, along with the Council Lobbyist Mike Sullivan, were all in attendance and all gave reports.

Guest speaker Representative David Gomberg of Oregon House District 10, Central Coast, addressed the council and talked about issues that were important to the coast and the rest of Oregon. David talked about logging on state and federal lands, Oregon log exports long with ocean wave powered electrical generation. Even though wave powered generation sounds good, it is still many years off until there will be a real return on the dollar investment.

AWPPW Local 13 Delegate Don Cadwallader asked for help on the water mixing zone rules and regulations which affect everybody. Don stated "Three of the biggest issues about mixing zones are agriculture run off, city treatment systems, and paper mills. We have to have food to eat, then we need to poop, and paper is a nice ending for the process." Don asked David to push back on any language that would hinder proper usage of mixing zones.

Senator Arnie Roblan, Oregon Senate District 5, Coos Bay, spoke to the council, covering issues related to the state's need to address the forest health of the Elliot Forest and the Tillamook Forest. Both of these forests are at a point in which there needs to be some logging done. If the state takes no action to properly log these lands, we could very well lose them to insect infestation and/or wild fires, both of which have happened years ago.

Representative Brad Witt, Oregon House District 31, Clatskanie, addressed the council about issues that affect both Oregon and Washington. Both states are having issues with the trains that are transporting oil. Rail safety is an issue that impacts everyone in both states. The railroads are working to build safer tanker cars: however currently the federal government, state government, and the railroads have not agreed on the safety standards for tanker cars or with standards for the rail system as a whole, including the oil offloading facilities. Brad thanked the council for the support they give him.

AWPPW Vice President Greg Pallesen discussed employers' actions, in the workplace, that drive safety incident and Page 6

accident non-reporting. Such activity is illegal and can be reported through the OSHA Whistleblower program. Local 677 Delegate Tim Wagner reported this year's safety conference will include the topic of management by fear and intimidation and issues impacting non-reporting of safety incidents and accidents.

Local 1 (St. Helens, OR) reported new paper manufac-For details on topics Lobbyist Mike Sullivan reported turing equipment is being installed. This year's local union picnic will be August 14th, with all members and retirees invited.

Local 13 (Toledo, OR) reported they are waiting for an answer from the arbitrator on a termination case; they have another arbitration case coming up in May. Georgia Pacific, Toledo, and the union created a new union safety coordinator position. Local 13 member Eddy Larson has agreed to fill the safety role. Local 13 also worked with G-P and the Oregon Department of Fish and Wildlife to put on the annual fishing derby at the G-P reservoir. As usual, the event was a success.

Local 60 (Newberg, OR) reported they prevailed in an arbitration case concerning the termination of an employee. SP Fiber Technologies is proceeding with their plans to restart the currently idled paper machine with plans to produce brown paper.

Local 78 (Portland, OR) gave an update regarding unfair labor practice charges the local has filed against their employer concerning security guards performing the bargaining unit's work, such as boiler inspections, and company security guards receiving shipments.

Local 677 (Springfield, OR) reported that they have re-



Local 83 Members Ratify 5 Yr. Contract

Area Rep Greg Jones reports the membership of Local 83 (Stockton, CA) ratified a contract with Pactiv in January. A summary of some features of the agreement is as follows:

Term — The term of the contract is five years, effective, retroactively, from November 30, 2012, to November 30, 2017.

Lump Sum Payments — Employees received a \$700 lump sum payment, plus another \$700 for ratifying the contract by January 31st, 2014. An additional \$850 lump sum will be paid employees on December 1, 2014, with the option of deferring this payment to their 401(k) accounts. The lump sum payments were to only be paid to employees that were actively employed on the effective date of the lump sum payments or if on approved medical leave and they returned to work within thirty (30) days of the effective date of the lump sum payment. Employees who were hired after January 1, 2013, will have a pro-rated ratification payment.

Wages — Effective November 30, 2015, there will be a \$0.40 per hour wage increase. Effective November 28, 2016, wage increases of 2% becomes effective for all employees.

Dental Plan — Dental cost comparison information to be provided by the company for the current AETNA dental plan and the proposed Delta Dental plans. Dental cost information for 2015 will be available in October, 2014. The company agreed to offer dental coverage to its employees during the life of this agreement.

Area Rep Jones thanks Local 83 Bargaining Committee members Mike Gomez, Glen Williams, Casey Freeman, Rodney Subia, and Adam Barajas for their steadfast work in these very long negotiations.
